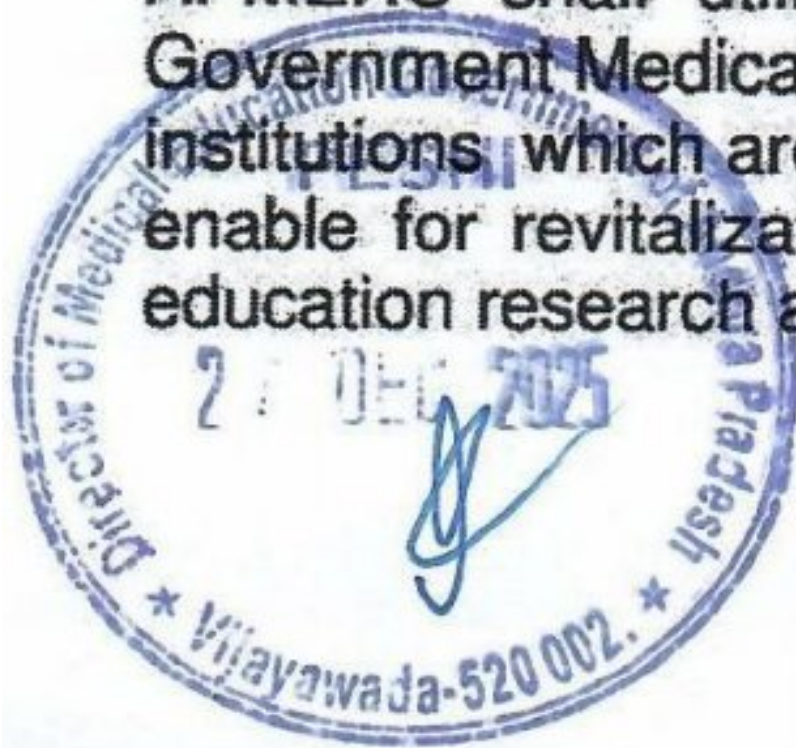
Vide reference 1st cited above, The Government, have accepted the resolution passed by the APMERC Board to categorize the seats in Government medical colleges permitted for Academic Year 2023-24 onwards as follows:

- I. 50% of total seats in each new government medical college shall be allocated to All India quota
- II. Out of the remaining 50% of the seats
 - a. 50% of the seats are categorized as Competent Authority (General Category).
 - b. 35% of the seats as Competent Authority (Self-financing).
 - c. 15% of the seats as Competent Authority (NRI Category).

Vide reference 2nd cited above, the Government, after careful examination, have fixed the fee structure as follows:

- a) Competent Authority (General Category) - Rs.30,000 per annum
- b) Competent Authority (Self-financing) - Rs.9 lakhs per annum
- c) Competent Authority (NRI Category) - Rs.29 lakhs per annum

Further, the G.O. mentioned that the amount collected under Competent Authority (self-financing) and Competent Authority (NRI category) seats shall be deposited with Andhra Pradesh Medical Education and Research Corporation. APMERC shall utilize the funds for the purpose of development of existing Government Medical Colleges, new Government Medical colleges and attached institutions which are incorporated in the Schedule of the APMERC Ad, 2021 to enable for revitalization of tertiary health care services and providing world class education research across the State.



Vide reference 3rd cited above, the V.C & M D of Andhra Pradesh medical education and research corporation has given approval to open one new bank account for collection of fees under Category B and one new bank account for collection of fee under Category C for each New Medical College in established scheduled commercial banks registered with the Reserve Bank of India.

In view of the above, the following savings bank accounts have been opened in Canara bank.
